Digital security Training;

About 30 young people: activists, feminists, human rights defenders and students attended a two (2) days training on Digital Security.

Topics discussed during the two days' workshop include:

- 1. Understanding digital skills and the need for 21st century
- 2. Online safety and cyber security: Phising, Doxing, 2-factor password authentication
- 3. Data privacy, states of data; rest, transit and use
- 4. Password management, types of browsers, types of malwares
- 5. Encryption and how it works Vs VPNs
- 6. Productivity tools



The activity was done 80% practical work and had the following outcomes:

• Participants were able to add a 2-step factor password authentication to all their social media accounts

- Participants got introduced to about five (5) productivity tools to help them in their day to day activities. They include; google drive, google doc, google sheets, google forms and jamboard
- Participants learned how to identify phising emails, safe URLs from fake ones

• Participants learned how to protect their data by encrypting their files, importance of setting strong passwords and the use of VPNs



RiWA team conducted two days' community dialogues in the Juba. Community dialogue forum drew participants from different sections of a community and creates the opportunity for exchanging information and perspectives, clarifying viewpoints, and developing solutions to issues of interest to the community

During the community dialogues, the team is presenting some of RiWA's key findings and following up on questions which the community members asked during the community feedback last summer. The objective of the dialogues is to fold.



The first objective is to share the findings with the communities in hope to stimulate conversation, understand the communities' interpretations of the findings, and identify possible actions that can be taken in the communities and by development actors.

The second objective is to reflect and learn from the dialogue experience and to continually improve the dialogues from site to site. In the end we hope to be able to provide recommendations to others who wish to share their findings with communities.

- 1. Public participation
- 2. Gender driven inequalities
- 3. Leadership Challenges
- 4. Peace and security
